


# Evolução das Políticas de Adaptação em Portugal

# Revisão da ENAAC em 2025 - Panorama da Adaptação




# Programa de Ação para a Adaptação (P-3AC)

Baseia-se no melhor **conhecimento científico** existente e em todos os exercícios de planeamento em adaptação à escala nacional, setorial e local/regional

Identifica principais **impactes e vulnerabilidades** do território nacional às alterações climáticas e **medidas de Adaptação** (prioritárias) para reduzir esses impactos e vulnerabilidades

**Guia** orientador para:

- Promover a implementação de ações de carácter mais estrutural
- Apoiar os exercícios de definição de políticas e os instrumentos de política e de financiamento



# P-3AC | #1 Prevenção de incêndios

- Regional systems for collection and interim storage of residual biomass from forestry and agriculture activities

VALORIZAÇÃO  
ECONÓMICA DA  
BIOMASSA

- (Re)forestation with fire resilient species
- Control of excessive densities of post-fire natural regeneration
- Agricultural mosaic
- Grazing areas to control spontaneous vegetation
- Shrub removal in areas adjacent to road, rail and built structures

FAIXAS E MANCHAS DE  
DISCONTINUIDADE

- Reconversion and reconfiguration of electric lines (e.g. underground cables, changes of route) and telecommunications networks
- Traffic warning, cut-off and diversion systems
- Information systems (e.g. surveillance systems, population warning)

# P-3AC | #2 Conservação e melhoria do solo

- Structures / natural barriers for erosion control in burned areas
- Consolidation and recovery of embankments and banks of watercourses favouring natural engineering techniques
- Restoration / rehabilitation of riparian areas
- Interlining of permanent crops
- Understorey and biodiverse pastures
- Green cover in soils in the rainy season and between the trees
- No-tillage; rotation of crops with different types of root systems



- Afforestation with soil improvement species
- Incorporation of manure and compost, rotations with legumes, cover crops and agricultural or forestry residues
- Use of livestock effluents, compost and by-products of agroindustries as fertilizer materials

- Infiltration gardens and other aquifer recharge solutions  
(e.g. trenches and infiltration channels)



# P-3AC | #3 Uso sustentável da água

- Reabilitação de sistemas de distribuição de água e monitorização de perdas
- Sistemas de rega por aspersão, micro aspersão e gota-a-gota em espaços verdes
- Espaços verdes com espécies adaptadas às condições edafoclimáticas locais
- Utilização de águas pluviais ou residuais na limpeza urbana, rega de espaços verdes e em sistemas de aquaponia/hidroponia



- Reutilização de águas residuais
- Aproveitamento das águas pluviais

- Práticas de regadio de poupança de água
  - sistemas por aspersão
  - micro aspersão e gota-a-gota
  - instalação de contadores nas captações
- Sistemas de monitorização das necessidades efetivas de água das culturas
- Remodelação das infraestruturas de rega
  - diminuição de perdas (transporte e evaporação)
  - otimização da capacidade de armazenamento
  - gestão mais eficiente de métodos e sistemas de rega
- Utilização de águas pluviais e reutilização de águas residuais tratadas
- Variedades com elevada produtividade da água e resistentes ao stress hídrico

# P-3AC | #4 Resiliência dos ecossistemas

- Focus on vulnerable species of fauna
- Creating of microhabitats in areas occupied by monocultures in agricultural and forestry ecosystems relevant to amphibians and reptiles
- Passage devices in dams for vulnerable freshwater and migrant fishes
- Wildlife passages/crossings on the highway and railroad
- Conservation of temporary pond systems

REFÚGIOS E CORREDORES  
ECOLÓGICOS

- Adaptation of existing *ex situ* breeding conditions at aquaculture centres
- Implementation of endemic endangered species *ex situ* breeding plans
- Promote and enhance the fauna and flora genetic heritage

CONSERVAÇÃO DO  
PATRIMÓNIO  
GENÉTICO

- Focus on the distribution areas of endemic species
- Focus on small intermittent coastal basins with endemic endangered species of freshwater fish
- Focus on relevant areas for the conservation of vulnerable amphibian and freshwater reptile populations
- Conservation and rehabilitation of watercourses, maintaining environmental flows and river continuum
- Regulation of abstractions for irrigation in summer refuges for vulnerable species of freshwater and migrant fish


# P-3AC | #5 Prevenção das ondas de calor

- Urban gardens
- Green roofs and facades
- Green areas
- Use of drought resistant vegetation and smart irrigation systems

**INFRASTRUTURAS  
VERDES**

- Warning systems for the general public and public transport users
- Awareness actions on heat waves events

**COMUNICAÇÃO**



- Shading areas (e.g. afforestation and exterior awnings and canopies between buildings)
- Ventilation corridors
- Thermoregulation by nebulization systems
- Drinking fountains
- Shading / cooling equipment in:
  - Public transport infrastructure and rolling stock (vehicles, stops & stations, parking lots)
  - Public buildings (schools, hospitals and health centres)
  - Private Social Solidarity Institutions supporting children and elderly

# P-3AC | #6 Espécies invasoras, doenças e pragas

- Valorisation of genetic material of agricultural and forest varieties and species in order to reduce susceptibility to emerging diseases and pests

VALORIZAÇÃO DO

COMUNICAÇÃO

- Identification of risk areas and mapping into an electronic platform
- Creation of a centralized system for agricultural and forestry warnings (biotic and abiotic agents)
- Development of platforms of information, early warning and entrance routes of exotic species

- Prevention, control and eradication of emerging vector-borne diseases of agricultural and forestry ecosystems
- Control of invasive exotic species and eradication at priority sites for vulnerable species

Enhancement of entomological surveillance through the expansion of the National Health Program for Surveillance of Culicidae Vectors

# P-3AC | #7 Proteção de cheias

- Cleaning and regularization of water streams
- Ecological restoration and maintenance of riparian vegetation
- Clearance of floodways
- Removal of sediment and other river bed materials
- Removal of obsolete structures with no current function

- Retention basins
- Reconversion of impermeable surface areas
- Retention ditches perpendicular to slopes

RECUPERAÇÃO DOS

ÁREAS DE

- Rehabilitation of existing dams for torrential correction
- Protection infrastructures
- Adaptation of infrastructures such as: transportation, energy, communications, sanitation
  - Elevation of infrastructure
  - Side shields
  - Drainage systems
  - Interventions in cut slopes
  - Relocation
  - Infrastructure stability

PROTEÇÃO

- Remodelling of stormwater drainage networks on critical areas
- Permeable and roughness paving suitable to flow conditions
- Preferential surface run-off pathways
- Stormwater retention systems
- Infiltration trenches or wells
- Infiltration areas
- Delimitation of preferential flooding areas and assure proper drainage conditions

- Maintenance / installation of hydrometric stations and updating of rating curves

# P-3AC | #8 Proteção costeira

- Coastal defence structures (e.g. rise in elevation and rockfill)
- Reinforcement or relocation of transport and communications infrastructures

RESTABELECIMENTO NATURAL

- Lagoon dredges for recharge of beaches, safeguarding the conservation of species and priority habitats
- Interventions to restore sediment in coastal systems
- Artificial feeding operations, including those of high magnitude (shots)

RECUO PLANEADO

Removal of structures and buildings in high danger areas and renaturalisation

- Reconstruction on non-existent or low danger areas
- Land acquisition / expropriation for risk mitigation

REabilitação de  
sistemas costeiros

- Naturalisation of dune systems with native species
- Maintenance and recovery of secondary dunes important for vulnerable species
- Protection and rehabilitation of coastal systems
- Interventions in cliffs
- Installation of appropriate warning signs



# P-3AC | #9 Capacitação, sensibilização e ferramentas

- Dissemination, education and awareness actions on climate change risks and adaptation measures
- Forecasting, warning and response systems


COMUNICAÇÃO

- Vulnerability assessment and adaptive management capacitation actions
- Production of information and knowledge, through monitoring of climate change impacts and risk mapping
- Development of Climate Change Adaptation Plans

CAPACITAÇÃO E PLANEAMENTO

- Establishment of national and sub-national monitoring and evaluation systems
- Development of tools to support decision-making and dissemination of good practices
- Development of a National Adaptation Platform
